**Information and Regulations:**

1. Event will be held Saturday March 25, 2017 from 9AM to 2PM.
2. Event space will be open to exhibitors only, starting at 7AM.
3. **Set up can be done between 5 pm & 7 pm on 3/24/17 if you choose to do so (Must be done by 7 pm)**
4. Booth must be attended at all times during the event. If exhibitor does not stay for the entire event, they will be invoiced an additional \$50 early exit fee and any remaining materials will be disposed of. Initial \_\_\_\_\_
5. Booth size is 10' x 10', see pricing below.
6. Each booth will have pipe and drape only, tables and chairs may be rented for an additional fee or you may bring your own.
7. All tables must be covered with a table cloth or skirt.
8. Additional booth space can be purchased at the listed price.
9. Any special needs or requirements need to be approved prior to purchasing booth space.
10. Booth location is on a first come first serve basis and subject to change without notice. We will attempt to place you at your request; however, no guarantees are implied or given.
11. Non-members can purchase a Chamber membership and receive the member price at time of booth registration.
12. Member pricing is available to all Members of all Neighboring Chambers that are in good standing.
13. In order to sell items at the Expo you must have a valid Anderson County Business License.
14. Booths cannot be shared unless you are a home-based business (no employees, no storefront, etc.), in which case you may share a booth with another home-based business.
