INTRODUCING: The Chamber Discount Card



This DISCOUNT CARD provides members with an average savings of 30% off Usual and Customary (U&C) Pricing; with savings as high as 75% on some medications. UNA Rx Card is designed as a stand alone benefit program but it may also be used as a supplement for insured prescription plans to cover non-formulary prescriptions. It can also be used as a Medicare Part D supplement by providing discounts on non-covered drugs.
